## **Model A Touring Recognition**

1. Purpose. The purpose of the Model A Touring Award is:
  - A. To provide recognition to those members who consistently drive their Model A Fords.
  - B. To provide an incentive which will encourage other members to drive their Model A Fords on extended tours.
  - C. To stimulate interest in Model A Fords by increasing exposure to the general public.
  
2. Qualifications and Requirements.
  - A. Only those persons who are current members of MAFCA will be eligible.
  - B. The Model A driver's touring badge and windshield decal will be issued to a member and his or her spouse who have driven their Model A Ford 5,000 miles or more within a one-year period of time. A separate award will be issued for 10,000 miles, or more, within a one-year period.
  - C. In addition to the 5,000 and 10,000 mile awards earned within a one-year period of time, cumulative mileage awards may be earned beginning January 1, 2003. All mileage accumulations will be on the honor system. The initial cumulative award will be at 25,000 total miles with successive awards at 50,000 and 100,000 miles.
  - D. The issuance of the badge and decal will be subject to the following conditions:
    - (I) The Model A (s) must be powered by an "A","B", or "C" engine. Those cars equipped with a Pinto or other late model engine will not be eligible.
    - (II) The miles need not be driven in one Model A. Two or more may be used, provided accurate mileage records are maintained.
  
3. Materials. All awards and recognition materials, i.e. patches and decals will be kept at MAFCA Headquarters. A nominal fee will be charged for these items.
  
4. Publicity.
  - A. Publish recognition in the Restorer.
  - B. Possible presentation of recognition at the National Meetings or National Conventions.
  
5. Recommendations for Clubs or Regions.
  - A. As necessary, the President of each chapter will designate an individual to administer the program within their chapter.
  
  - B. When an individual member or group of members desires to qualify, they must notify the designated person in their chapter, who will in turn record the date and starting mileage reading. This person shall verify and certify that the required mileage has been driven by keeping records of the speedometer mileage readings on an annual basis.

- C. Upon achievement of the award level, the designated person shall submit to MAFCA the name(s) of those persons qualifying, as well as a copy of the mileage records. They shall also submit the appropriate fees to cover the cost of the desired patches, decals, etc.
- D. Allowance for change in speedometer, broken speedometer, etc. may be made, based on accurate records as submitted by the chapter representative to the MAFCA Board of Directors.
