

## **MAFCA Honorary Life Membership Award**

1. Purpose. The purpose of the MAFCA Honorary Life Membership Award is to provide special recognition to those dedicated MAFCA individuals who have, through their significant, continuing and unusual efforts for the betterment of the Model A Ford hobby, shown a special commitment to the Model A Ford Club of America. (Note that the title of the Award was changed 12/10/2010 upon MAFCA Member ratification of a Revision to the Bylaws. The Award was not changed.)
2. Cost. Recipients shall become a Family Member for his/her lifetime at no cost to him/her. Each recipient's name shall be inscribed on the Honorary Life Member plaque which recognizes all Honorary Life Members. Each recipient shall receive a Honorary Life Member lapel pin and a Honorary Life Member certificate attesting to the honor.
3. Nomination. Any Model A enthusiast who has been a member of MAFCA for 20 years may be considered for nomination as a Honorary Life Member, the exception being a nominee shall not be a current member of the MAFCA Board of Directors nor served on the Board for the last four years. The nomination shall be in written form, signed by the Nominator, and endorsed by a minimum of four additional persons, all of whom must be MAFCA members. This Award is the highest recognition that a MAFCA member can receive. Thus the contributions must be significant and extend over a sustained period such that there is no question as to the worthiness of the nomination. Ten years of service at the National level is the guideline for the definition of "sustained period". The attached nomination form must be completed; a cover letter noting the important accomplishments of the nominee may be included.
4. Review Committee. Upon receipt of a nomination(s), a Review Committee shall be appointed to consist of the current MAFCA President and two Past Presidents and approved by the Board of Directors. Upon review of the nomination(s), the Review Committee shall submit their recommendations to the Board of Directors for action.
5. Presentation. Upon approval by the Board of Directors, the Honorary Life Membership Award shall be presented to the recipient at the earliest National Convention or Annual Awards Banquet or some other appropriate time and place.
6. Rights. A Honorary Life Member shall be extended the same Rights as a Family member but shall be exempt from payment of membership dues for his/her lifetime. Upon the death of a Honorary Life Member, a surviving spouse shall continue to receive the Family Rights and shall be exempt from payment of membership dues during his/her lifetime.
