

**MAFCA Sanctioned Meets**

1. Purpose: To set forth procedures and guidelines to allow the MAFCA sanctioning of a meet for purposes of MAFCA car and fashion judging credit and presentation of MAFCA awards.
2. Procedures: MAFCA Regional and Chapter sponsored meets may be sanctioned to perform car judging, fashion judging or both by agreeing to hold these activities in accordance with prescribed MAFCA standards. To receive MAFCA sanctioning for either car or fashion judging, the host group must be a currently registered MAFCA entity. Judges must be current MAFCA members to receive MAFCA judging credit. Participants must be current MAFCA members to receive MAFCA awards.

The Host Group will submit the request for sanctioning to the Judging Standards Committee (JSC) and/or the Era Fashion Committee (EFC). The JSC and EFC will submit their recommendation regarding approval to the MAFCA Board of Directors for final consideration. If the request is approved, the JSC and/or the EFC will inform the Host Group Coordinators of the decision and provide them with the necessary information, assist in the validation of judges and judging levels required. The procedures for judging will be in consonance with the Judging Standards and the Fashion Guidelines. Awards given will meet the criteria and be as outlined in these publications.

3. Responsibilities: Host Group coordinators must submit the Sanctioning Application to the JSC and the EFC at least six (6) months before the event to allow processing of the request. MAFCA sanctioning is not required for any meet when there is no objective to officially credit judges for their work or provide MAFCA level awards.

**REQUEST FOR MAFCA FASHION JUDGING SANCTION**

In order to receive credential credit for fashion judging, MAFCA must sanction the event. To do this, send your request, using this form, to the Era Fashion Chairperson at MAFCA Headquarters. This should be done as soon as you know you will have fashion judging, but no later than 6 months prior to the meet. You will be notified when the approval has been received.

7. Fashion judging must be conducted in accordance with The Fashion Guidelines.
8. You must provide MAFCA headquarters with a list of entrants, scores and awards within 45 days after the meet.

Upon receipt of this form you will be mailed, free of charge, a copy of the Fashion Judging Procedures Manual, which will give you all the information you will need. Your Chief Judge will also receive a copy of the FJPM.
