1. Active membership in the Model A Ford Club of America.
2. At least 18 years of age.
3. Experience with local, regional, or national MAFCA activities.
4. Nomination shall not be for a third consecutive term as a Director.
5. Three current letters of reference by active MAFCA members.
6. One passport-sized or larger photograph suitable for the ballot.
7. An accompanying letter of not more than 150 words describing your leadership experience in MAFCA, MAFCA Chapters, or the business world, including, as appropriate, your experience with computers and other modern business tools. Any Model A activities or ideas that would be beneficial as a National Director may be addressed. If your candidacy is approved, this 150-word statement will appear verbatim on the election profiles.

In accordance with the MAFCA Bylaws, Article V, Section 3.1, I submit my name as a nominee for the position of National Director for the two-year term commencing upon Installation at the MAFCA National Awards Banquet following election. My responsibilities will include attendance at approximately six meetings a year. As a National Director, I also understand that MAFCA may reimburse my travel and hotel expenses.
